Release of Liability and Assumption of Risk Agreement

I, the undersigned, in consideration of my or my child's participation in this program, agree to indemnify and hold the City of San Carlos harmless and release the City of Carlos, its officers, employees, and agents from any and all liability for any injury or damage arising out of, or in any way connected with participation in this program. If the participant is a minor, give my consent to his/her participation in the said program and related activities.

I, the undersigned, in consideration of participation in the program, hereby waive, release and discharge any and all claims for damages for death, personal injury or property damage which I may have, or which may hereafter accrue to me or my child, against the City of San Carlos as a result of my or my child's participation in the program. This release is intended to discharge the City of San Carlos, its officers, officials, employees and volunteers, and any other involved municipalities or public agencies from and against any and all liability arising out of or connected in any way with my or my child's participation in the program. I further understand that accidents and injuries can arise: knowing the risks, nevertheless, I hereby agree to assume those risks and to release and hold harmless all of the persons or agencies mentioned above who (through negligence or carelessness) might otherwise be liable to me (or to my heirs or assigns) for damages, except where caused by active negligence, sole negligence or willful misconduct of the City of San Carlos. It is further understood and agreed that this waiver, release and assumption of risk is to be binding on my heirs and assigns.

In case of emergency I hereby give my permission for City of San Carlos employee and/or the City of San Carlos to order/authorize medical treatment for me or my child.

DROP-IN BEHAVIORAL CONTRACT
For Year June 2019 through June 2020**

**All participants will be expected to comply with the following
Behavior Standards while at the San Carlos Youth Center**

- Bring your YC Membership Card every day. Check in with it at the front desk
- Respect and listen to all Youth Center Staff Members. They are here to help and protect you
- Swearing, name calling and put-downs are NOT allowed and will not be tolerated
- If you have a disagreement with another participant, talk it out with them. The YC Staff Members will assist you if you need help
- Do not touch the property of other participants
- Respect all of the YC equipment. Each item should only be used for its intended use
- Throw all trash away in the proper receptacle
- If you check an item out, check it back in when you are finished. This includes games, sports equipment, and homework supplies
- Roughhousing and wrestling are not allowed. Keep your hands to yourself
- Do not climb on tables, chairs or other furniture
- Throwing items of any kind is prohibited, unless the item is a ball in the Gym
- All bikes must remain outside, locked to the bike rack
- Bikes, skateboards, and scooters are not allowed in front of the YC or in the parking lot
- Participants must clean up any mess they make
- The City of San Carlos is not responsible for any lost or stolen articles
- Before playing a game, agree on the rules with each participant
- If you break it, you buy it. This applies to all equipment and furniture
- If a piece of equipment is broken, notify a YC Staff Member immediately
- The Homework Room is a NO TALKING area. Please do not talk while in that room
- **Video games are a privilege.** Excessive yelling will result in loss of game time.
- Help keep the Youth Center a fun and safe place by following these rules!
